1. Purpose

This Policy supports Access 2 Place to comply with the <u>Community Housing Core Operating Policy</u>: <u>Disability Access and Inclusion</u>.

2. Context

This policy has been developed to support the goal of providing opportunities for people living with disabilities to exercise greater choice in housing.

3. Scope

This policy applies to properties subject to or bound by a Community Housing Agreement between Access 2 Place Housing (A2P) and the South Australian Housing Trust (SAHT). This Disability Access & Inclusion Policy should be read in conjunction with the <u>A2P Specialist Disability Accommodation (SDA) Policy</u>.

4. Risk

A2P's failure to respond to disability access and inclusion objectives, particularly the provision of disability modifications for tenants with a disability, may limit a tenant's independent living conditions and risks non-conformance with the relevant legislation for persons with a disability.
